I am directed to state that it has been decided to hold the LICE for promotion to the post of Rajbhasha Adhikari on **23.05.2010 (Sunday)** as per the pattern, scheme and syllabus circulated vide letter No. 27-2/2005-Pers.II dated 16-08-2005. The eligibility, service conditions and other details for appearing in the said examination will be as prescribed in Recruitment Rules of Rajbhasha Adhikari circulated vide letter No. 22-35/2001-Pers.II dated 5th August, 2005. The test will be held at the Headquarters of the territorial Circles and such other centers as may be fixed by CGMs.

Pushpawali Singh against the judgement dated 27-11-2007 of Hon'ble High Court of Calcutta in FMA No. 1395/2007 arising from MAT No. 473/2006.
